ALL horses must be accompanied by a current EIA (Coggins) test dated within 12 months of show and Health Certificate within 30 days. The MFTHBA Board of Directors recommends that all horses be vaccinated for flu.

Exhibitor understands that by signing this form he/she grants permission to the MFTHBA to use any video film and/or pictures of the exhibitor or their horse for any advertising, promotional or educational purposes and holds MFTHBA harmless of any liability.
