



# MFTHBA Pay-to-Park Storage Agreement

(herein "the member") and The Missouri Fox Trotting Horse Breed Association (herein "the MFTHBA").

**For good and valuable consideration, the MFTHBA and the Member agree as follows:**

1. **Scope:** This Agreement shall apply to any and all Recreational Vehicles held in storage in a designated storage spot. For the purposes of this agreement, "Recreational Vehicle(s)" shall mean/refer to motor homes, fifth wheels, tag-a-longs/travel trailers, pop-ups and/or living quarter horse trailers. The recreational trailer the member intends to store at the MFTHBA may further be described as follows:

2. **Fees and Payment:** Member agrees to pay a fee of \$50 to store RV on the MFTHBA grounds in a designated storage area, between the Spring Show, held in June, and the Celebration, held in September.
3. **Liability and Release:** The member agrees that all storage is at Member's risk. The MFTHBA does not monitor or supervise Recreational Vehicles stored under this agreement. Nor can the MFTHBA ensure that such vehicles or the contents thereof will be protected while stored. Members are advised not to store valuables in their Recreational Vehicle. MFTHBA shall **NOT BE LIABLE** for any damage that may occur to Member's Recreational Vehicle or its contents stored pursuant to this agreement. The Member specifically releases MFTHBA of any liability resulting from loss, glass breakage, vandalism, collision or other harm.
4. **Terms of Agreement:** Through this Agreement the Parties agree to be bound by the following terms and conditions.
  - A. Member agrees that RV will be moved from Storage Area no later than two days before the September Horse Show begins.
  - B. Member must report to the office when an RV is removed from the Storage Area.
  - C. The Member warrants that he/she will reimburse, indemnify and hold the MFTHBA harmless for any damage to the MFTHBA property, the Member's property, or the property of other members caused by the Member's Recreational Vehicle, by the Member or other licensee (person) removing the Member's RV from the Storage Area.
  - D. This agreement shall be constructed under and governed by the laws of the State of Missouri. Any and all disputes regarding the interpretation or enforcement of this agreement shall be instituted and maintained in any court of competent jurisdiction in the county of Douglas, State of Missouri.
  - E. The MFTHBA shall be entitled to reimbursement for reasonable attorney's fees incurred as a result of the Member's breach of this Agreement.
  - F. The Member represents that he or she or any licensee of the member who is moving any Recreational Vehicle into or out of the Storage Area will maintain a level of liability insurance at a level consistent of Missouri Law.
