Nominations: 2023 foals shall be nominated per deadlines and nomination fees listed per item E below. Postmark acceptable for all but May 30th deadline. All fees and forms must be in the MFTHBA office by 4:30pm on May 29, 2026 for horse to show.

- A. Entries must be made with markings (in detail) and color on the entry blank.
- B. All entries and fees are to be sent to the MFTHBA Office in Ava, Missouri.
- C. A sufficient number of nominations, as determined by the Board of Directors, must be received by January 1, 2026 or fees will be refunded.
- D. All entries shall abide by the MFTHBA Rules.
- E. Entry fees are as follows: Nomination on or before October 31, 2025, nomination fee \$40.00. The first installment of \$40.00 will be due December 10, 2025, no payment due in January, and the following three installments of \$40 each, due the 10th of each month February-April. Horses paid up by October 31st will receive a 10% discount or a total cost of \$180.00. All horses must be paid in full, including all applicable late fees by May 29, 2026. Postmark is NOT acceptable for the May 29 deadline.
